YNLR is pleased to present our spring community newsletter. YNLR's governance and staff have been busy advancing our mandate to promote and enhance the social, environmental, cultural and economic well-being of current and future Basin residents.

We're pleased to welcome another exploration company, IsoEnergy, as a partner in the region in support of their projects. This brings our total number of exploration company partners to 8 with more soon to be announced. Our Community Land Technicians have been busy working with the youth, Elders and other Basin organizations in supporting the practice of Treaty rights, provision of fish and wood as well as advancing our Indigenous Protected Areas. YNLR staff and board were busy presenting our work on cumulative effects at a conference in Calgary as well as presenting at a Canadian Space Agency conference on Earth Observations in Montreal.

Of most significance over the past few months was YNLR's participation and support of the Education, Training and Employment Summit in Saskatoon where over 100 people from industry, government, institutes and the Basin communities attended to share valuable insights on identifying and advancing priorities to support education, training and employment in the seven Basin communities. YNLR is grateful to our leadership for supporting the event and to sponsors Athabasca Basin Development and PrairiesCan.

YNLR has been busy these past few months and we appreciate the new partnerships we are establishing with government and industry. We continue to strengthen our existing partnerships in support of our mandate. YNLR and our leadership welcome the increasing interest from industry and government for resource development in Nuhenéné and we look forward to balancing this interest with the establishment of protected areas and partnerships that bring increased value to all Basin community members.

#### **NATOA Trust and Investment Conference**

The 11th Annual NATOA Trust and Investment Conference was held in Montreal, Quebec from April 3rd to 4th. The purpose of the 2-day event was to bring together trustees and industry experts from across the country to knowledge-share, network, and plan for the future of Indigenous trusts and investments. TD Wealth and Indigenous Trusts invited Celeste Robillard to speak on the TD panel on behalf of the community trustees of the Athabasca Community Trust (ACT) at the conference.

The panel was titled "Community Funding for Impact" and discussion was about what is considered critical when evaluating and managing funding of projects and proposals, as well as experiences and challenges with deciding how to allocate funds, setting a strong foundation, and communication tips. Discussion points from Celeste included the successful water filters project in Uranium City, the importance of community trustees as the decision makers for the Athabasca Community Trust as well as the challenges with proposals and how to address those challenges by a pre-screen of proposals and face to face communication with applicants. The panel was a breath of fresh air on day 1 of the event and the crowd appreciated hearing from those that directly work with community members.

## IsoEnergy Collaboration Agreement


Ya'thi Néné Lands and Resources is pleased to announce we have recently entered into a Collaboration Agreement with IsoEnergy Ltd.

## **Indigenous Protected Areas**

#### **Collaborative Discussions with Industry Partners**

In a spirit of collaboration and dialogue, the team at Ya'thi Néné Lands & Resources (YNLR), joined by Chief and Council members from Black Lake Denesyliné First Nation, convened for a series of meetings on April 16th and 17th, 2024 in Saskatoon, SK.

These pivotal sessions involved engaging with multiple industry companies, all centered around the Indigenous Protected Areas (IPA) project. Each meeting, spanning an hour, was conducted with individual participating companies. This structured approach allowed for thorough discussions and meaningful exchanges, ensuring aspects of the IPA project were comprehensively addressed.

These interactions serve as a testament to our commitment to fostering partnerships and transparent processes within our community. Stay tuned for further updates as we continue to advance our shared goals together!

#### What is an Indigenous Protected Area?

IPAs are usually defined as conservation areas whose creation and ongoing management are Indigenous led, with Indigenous Peoples having the primary role in determining what is important to that specific IPA. This includes things like the values and objectives that are identified as sacred, boundaries of the IPA, the management plans for the governance the and structures for the IPA.

For the Nuhenéné IPA, this means that the Athabasca Denesuliné decide what values and priorities will guide and direct all work being done to develop protected areas. The community members participate in the process of determining where the protected areas will be located and their size. Elders, youth, leadership, and land-users are involved every step of the process. This is Nuhenéné, and it is important that everyone has the opportunity to have their input.

#### Exciting News: Launch of Socio-Economic and Conservation **Economy Study**

In our ongoing efforts to foster a sustainable and diverse economy rooted in the traditional stewardship of our natural and cultural heritage, the Athabasca Denesyliné First Nations and communities are embarking on a groundbreaking initiative. We are thrilled to announce the commencement of a comprehensive Socio-economic and Conservation Economy Study, focusing on Nuhenéné (SK).

Made possible through funding from our partners at Parks Canada, this study aims to explore the vast potential for building and sustaining conservation economies through the establishment of Indigenous Protected Areas (IPAs).

YNLR is delighted to lead this project, which will provide a holistic overview of the socio-economic landscape in the Athabasca Denesyliné First Nations and surrounding municipalities. Our dedicated team will identify crucial data gaps specific to Nuhenéné and devise strategic plans to address them.

To undertake this important work, we have engaged the expertise of Anielski Management Inc. Mark visited the communities in early June to share insights and seek input, ensuring that this study authentically represents the aspirations and realities of the Athabasca region.

Stay tuned for further updates as we embark on this important work together, shaping a future where our communities thrive in harmony with our cherished natural and cultural heritage.

Moving forward, we are pleased to continue to grow our partnership with the Province and utilize the Province's Protected Conserved Area Network (PCAN) strategy in support of our work. The bonds forged and agreements reached during this pivotal meeting signal a promising path forward in balancing our conservation endeavors and responsible resource development in Nuhenéné.

#### **Community Visits: IPA Updates**

From June 9th - 12th, the IPA team visited the communities of Uranium City, Camsell Portage, Stony Rapids, Black Lake, and Hatchet Lake. Our visit to Fond du Lac has been postponed, so stay tuned for the new date!

#### Caribou Scouting near Fond du Lac

This was my first field trip since working at YNLR and it was an exciting opportunity to explore new places, as our guide Andrew Isadore led us through some traditional hunting routes. Along the way, we saw old caribou tracks heading north on Gardiner Lake, indicating they had been there. Although we didn't spot any caribou, the trip was filled with memorable experiences exploring areas I'd never seen before.

We ended our trip by visiting the recently built ADNLC cabins at Ivanhoe Lake and Smith Lake, within the proposed IPA. The cabins had not been used this season due to lack of caribou in the Fond du Lac area, but we still cleaned up the cabin sites and stacked wood for future visitors. The cabins were in excellent condition, ready to host future travelers.

I want to thank Andrew Isadore for guiding us and Tina Giroux-Robillard for the opportunity to participate in this journey. I am looking forward to what's in store for the upcoming summer months.

After speaking with them, we gathered feedback and noted the general struggle due to a lack of sufficient cabins. Hunters expressed their hopes for more cabins in the future, which would support their activities and the Denesyliné tradition of caribou hunting.

The efforts of our Community Land Technicians highlight the dedication to preserving traditions and supporting the community. Their work ensures that both the land and the cultural practices tied to it are maintained for future generations.

Over the last several months, YNLR's CLTs have shovelled snow and sanded walkways, cleaned up outdoor areas, and provided water, wood, fish, and geese to Elders in their communities.





#### Athabasca Basin Education, Training, and Employment Summit

On March 13-14, 2024, the Athabasca Education Employment and Development Committee (AEEDC) held an Education, Training and Employment Summit in Saskatoon to bring together interest groups that live, work, or operate in the Athabasca Basin to build consensus on strategic priorities and actions moving forward.

The agenda for the Summit included presentations of activities related to education, training and employment in the Athabasca Basin, panels representing these areas, and various stakeholder addresses and industry contributions. We appreciate the comments provided by MLA Jim Lemaigre of the Saskatchewan Government and Minister Dan Vandal of the Federal Government to help kick off the event. The activities included Ice Breakers, Keynote Speakers, Panel Discussions, Visioning and Action Workshops.

A significant number of attendees approved of the assigned working groups and found it extremely valuable to be introduced to and work alongside individuals from different sectors. This format encouraged relationship-building, knowledge, and resource sharing, and resulted in strong, meaningful consensus on future visions, goals, and actions. A key takeaway from the engagement findings is the need for continuous collaboration. Events such as the Summit are seen as highly valuable by attendees and there is a shared desire for more opportunities to come together regularly.

A draft overview of the 10 Recommendations identified included "Establish a Governance Framework, Stakeholder Engagement Plan, Modernize Infrastructure, Develop Workforce Capabilities, Enhance Educational Facilities, Curriculum Development, Promote Health and Wellness, Foster Entrepreneurship and Economic Growth, Cultural Preservation and Integration and a Needs Assessment Framework and Program Evaluation."

Guiding Principles were also identified, which included "Respecting Language and Culture, Consistent Communication, Consultation and Negotiation, Prioritizing Youth and Elder Input, Focus on Holistic Well-being and Be Community-driven".

Once the report and its findings are reviewed and confirmed by leadership, this analysis will be used to begin work on the strategic action plan. The anticipated action plan will break down the recommendations into deliverables with associated tasks, objectives, and milestones. These plans will then be shared with key government, institute and industry partners.

The AEEDC would like to thank the organizations from all sectors, government, keynote speakers, panel speakers and participants who attended and provided their participation and contribution for a successful Summit that was made possible by financial contributions from PrairiesCan and Athabasca Basin Development.

#### **Cumulative Effects Conference**

YNLR recently attended the 12th National Symposium on Cumulative Effects Assessment and Environmental Management, held in Calgary, AB on April 9-10, 2024.

At the symposium, we learned more about current and future practices in cumulative effects and environmental management, with an emphasis on Indigenous Rights, Cumulative Effects Assessment (CEA), and Regulatory Processes.

Bruce Hanbidge, our Strategic Advisor, and Kathy Hay, Manager of Corporate Affairs, shared a presentation titled "Assessing Cumulative Effects in the Athabasca Dene Traditional Territory (Nuhenene) of Northern Saskatchewan" with members of the mining industry, regulatory bodies, and Indigenous groups.

The presentation focused on the threats faced by the Woodland Caribou, the overall ecological integrity of the area, and the Denesyliné culture. We emphasized the Denesyliné community's efforts to protect and preserve our land while supporting mineral exploration and extraction at levels that are both ecologically and socially sustainable. We remain committed to advancing sustainable practices and encouraging meaningful partnerships that prioritize environmental stewardship and Indigenous rights.

#### **Earth Observation Forum**

In May, YNLR was invited to Canada Space Agency's 2024 Earth Observation Forum in St. Hubert, QC. Mary Denechezhe (Board Chair, Hatchet Lake), Archie Disain (Board Director, Black Lake), Jean Tsannie (Community Land Technician, Hatchet Lake), and Megan Wallace (Environmental Land Use Planner) attended on behalf of YNLR.

The focus of this conference was to review the recent missions for satellite imagery completed by Canada Space Agency and to look at what is planned in the coming years. One interesting mission is a new satellite that is targeted to monitor and identify potential forest fire locations and track the size and severity of burns.

Mary opened the conference with words of wisdom and opportunity that resonated with attendees. YNLR was also asked to participate in a session called "Sharing Stories about Indigenous Wisdom, Earth Observation and Mapping." Mary and Megan gave a presentation highlighting some of the challenges faced by Nuhenéné with ongoing disturbance from resource development, impacts from climate change, and how we are presently using satellite imagery to help identify ground disturbance. The reception to the session was astounding and indicated by many as the highlight of the conference. We challenged Canada Space Agency to expand on data sharing and accessibility, particularly for Indigenous organizations.



#### **Update on Orano Exploration Activities**

The 2024 winter exploration programs in Waterbury-Cigar, Waterfound River and Midwest ended during the first week of April. All the planned drilling activities were completed consisting of 38 drill holes, totaling 17,938m. The Orano team and contractors have been utilizing Points North and McClean Lake as bases for this work.

The ground geophysical surveys planned at Close Lake, Waterfound River and Waterbury-Cigar were shortened or postponed due to challenging weather conditions and early snowmelt that could not ensure safe activities.

On the west side of the province, at the Preston Lake project, south of Patterson Lake, the planned ground geophysical survey has been completed. The geophysical program for the Marguerite River was canceled due to poor ground conditions again due to early snowmelt.

Orano will commence drilling operations again in June for the Waterfound River project along with a revised ground geophysics that was not completed this winter. Crews will once again be based in Points North. Consideration will also be made to perform geophysical survey adapted to the dry conditions in Close Lake and Waterbury-Cigar.

For the west side of the province, a soil sampling program of 1,100 soil samples is also scheduled during the summer at Preston Lake.

Orano exploration team is ISO 14001:2015 and ISO 45001:2018 certified and plans projects to prioritize the health and safety of the team and minimize potential impacts to the environment.

#### **Introducing Lesley Schmalz & Walter Smith**

Orano Canada has a new Regulatory Manager working in Saskatoon! Meet Lesley Schmalz, who has returned to Orano after a 5-year hiatus with the Saskatchewan Ministry of Environment.

Prior to working with the Province, Lesley worked at the McClean Lake Operation as a Regulatory Relations Coordinator for 11 years. Lesley is excited to be back and is looking forward to visiting the northern communities and reconnecting with former co-workers and meeting new people.





We are also pleased to welcome Walter Smith as the Senior Indigenous Engagement Specialist for the company. Walter brings a broad spectrum of lived experience achieved from blending his professional career, academic education and Indigenous knowledge.

Walter and his wife Laurie currently live in Martensville with their family. Hailing from Pinehouse, Walter is a member of the Lac La Ronge Indian Band, and someone with over thirty years experience in the mining

industry and community development. Most recently he was employed as the Environment, Education and Training Manager at Kineepik Metis Local. He enjoys the northern lifestyle and cultural practices and will continue to work on his fluency in the Cree language. He also looks forward to learning more of the Dene language once again.

Cameco has submitted an application requesting a release from Canadian Nuclear Safety Commission (CNSC) licensing requirements. A public hearing with the CNSC regarding this application has been scheduled for January 29, 2025.

For those interested in participating in the hearing process, the CNSC has made funding available through the Participant Funding Program. Participant funding applications are due June 21, 2024. Interventions are due on December 10, 2024.

# Your Community Land Technicians are here for you.

Ya' thi Néné's purpose is to protect the land, water, and air of Nuhenéné and to promote the people of the Denesyliné First Nations and Athabasca communities that reside there.

That's why we're always on the lookout for issues and observations from residents of the Basin. If you or someone you know has an observation, notices something, or hears a concern related to the land and water, we ask that you report it to one of our Community Land Technicians (CLTs).

When you make a report to your CLT, they will take the time to listen to your concerns and ask you questions. After collecting as much information as possible they will refer the issue to our head office, where research and analysis will be done and actions to resolve the issue will be determined.

Updates will be provided to the person(s) who reported the issue on a regular basis. Issues that are successfully resolved will be communicated to the communities.

Some examples of issues that could be reported include:

- Seeing an outfitter abandoning an out-post camp, leaving debris and garbage
- Finding an abandoned exploration camp with waste left behind
- A sick or diseased animal (e.g. fish with unknown cysts)
- Observations on changes to the environment (animal behaviour, habitat, etc.)
- Issues with hunting/trapping/fishing/gathering
